

DECLARATION OF AUTHORISED OFFICER in accordance with Regulation 126 *Fair Work (Registered Organisations) Regulations 2009*

ALTERATION OF OTHER RULES OF ORGANISATIONS in accordance with section 159 of the *Fair Work (Registered Organisations) Act 2009*

I, David Genford of 32 Patrick Street, Hobart, Tasmania, am the President of the Australian Education Union – Tasmania Branch and am authorised to give this notice of particulars of alterations to the rules of Australian Education Union – Tasmania Branch and to make this declaration as required by Regulation 126 of the *Fair Work (Registered Organisations) Regulations 2009*.

1. I declare that the alterations were made in accordance with the rules of the Australian Education Union – Tasmania Branch
2. The particulars of the rule alterations are attached to this declaration and labelled '*Schedule A*'.
3. The actions taken under the rules to make this alteration were as follows:
 - (a) The Tasmanian Branch Deputy President emailed the proposed rule changes to the State Manager on 23 March 2026. See attached "*Schedule B and Schedule C*"
 - (b) The Tasmanian Branch State Manager sent notice to Branch Council members on 15 April 2026 (with a copy of the proposed rule changes) calling an Extraordinary Branch Council Meeting for 6 May 2026 to vote on the amendments.
 - (c) "*Schedule D*" - Agenda for the Extraordinary Branch Council meeting held on 6 May 2026.
 - (d) The Extraordinary Branch Council Meeting happened on 6 May 2026 and the rules were voted on as per point (f)
 - (f) 16 members attended the Branch Council Meeting plus 4 proxy votes. Current membership is 38.

As such the meeting was quorate.

Rule change 1: Rule 32 (2) 20 voted in support

Rule change 2: *Add new rules 42 to 44 and move current rule 42 and re-number as 45. Amend rule 38 (12)* 20 voted in support

Rule change 3: Add and amend rules 5,7 and 32 and Schedule B
20 voted in support

Rule change 4: Rule 5(1), 5 (2)(a), 5 (2) (b) 20 voted in support

Change 5: Any reference to DoE and Department of Education be replaced with DECYP, and any references to facsimiles be removed. See attached "*Schedule E*"
